DEFINITIONS OF LICENSE CLASSIFICATIONS

The following definitions apply to family and group family childcare:

NEWBORN:	Birth to 6 weeks (All license classes)
INFANT:	6 weeks to 1 year (All license classes)
TODDLER:	1 year to 2 1/2 year (Class B1, B2, D) 1 year to 2 years at (Class A, C1, C2, C3)
PRESCHOOL:	2 1/2 years to within 4 months of being eligible to enter kindergarten. (Class B1, B2, D) 2 years to within 4 months of being eligible to enter kindergarten. (Class A, C1, C2, C3)
SCHOOL AGE:	Children who are within 4 months of being eligible to attend kindergarten to 11 years of age. (All license classes)

CLASS A

- A total of **10** children. (Provider must include all her own children under the age of 11 years in her enrollment).
- Of that total, **4** may be school-age children and; **6** may be under school-age.
- Of the children under school-age, no more than a total of **3** may be infants and toddlers and; of those children, no more than **2** may be infants.

CLASS C1

- A total of **10** children. (Provider must include all her own children under the age of 11 years in her enrollment).
- Of that total, **2** may be school-age children and; **8** may be under school-age.
- Of the children under school-age, no more than a total of **3** may be infants and toddlers and; of those children, no more than **2** may be infants.

CLASS C2

- A total of **12** children. (Provider must include all her own children under the age of 11 years in her enrollment).
- Of that total, **2** may be school-age children and; **10** may be under school-age.
- Of the children under school-age, no more than a total of **2** may be infants and toddlers and; of those children, no more than **1** may be infants.

CLASS C3

- A total of **14** children. (Provider must include all her own children under the age of 11 years in her enrollment).
- Of that total, **4** may be school-age children and; **10** may be under school-age.
- Of the children under school-age, no more than a total of **4** may be infants and toddlers and; of those children, no more than **3** may be infants.
